## Hire Car Drivers Form – Letter of Authority

Only the person that is listed on this Car Rental Agreement and above the age of twenty-one may drive this vehicle. The above mentioned Car Renter is hereby responsible for all collision damage to the vehicle regardless if someone else is at fault or the cause is not known. The Car Renter is fully responsible for the cost of any repair up to the value of the vehicle. The Car Renter's Insurance may cover all or only part of the financial liability for the rented vehicle.

The Car Renter is hereby bound by the terms and conditions of this Car Rental Agreement. The vehicle must be returned to the location detailed in their itinerary on or before the indicated due back date and time. There will be additional fees due if the vehicle is not returned as specified above.

The individual mentioned above in this Car Rental Contract hereby agrees to fill the fuel tank in full upon returning the car. Failure to fill the tank to its full level will result in additional charges.

It is the Car Renter's responsibility for all lost car keys and / or a lockout situation.

I consent to the submission of all charges regarding Fuel, Damage, Excess Kilometers, Trailer Hire, Extra Days Hire after original return time and any infringements associated with the rental by the above named individual, authorized by this document, to my credit/charge facility for the payment to the owner. I acknowledge the fact I will be liable for all additional charges relating to this Rental Agreement until the safe return of the vehicle to the authorized rental car location.

I also acknowledge that the charges are subject to a final audit and are aware that I will be liable, if necessary, for any excess or vehicle damage charges as detailed on the rental agreement. In the event that the credit/charge card company, if for any reason whatsoever, does not pay the hire company for the charges incurred by the individual authorized, I hereby agree unconditionally agree to pay such amounts to the hire company Any such payments will be made within ten (10) days notice from the hire company
